Motion by J. Trites to accept the petition brought to the board by Jack Rosenthal requesting acceptance by the township of Foursquare Road as a township road to be maintained by the township. A hearing date for September 21, 2019 at 9:00 a.m. at the Town Hall and then proceeding to the roadway is set. The township will hire engineer, Jeff Stabnow to make sure Foursquare Road and Spanswick's Road meet township specifications. Seconded by Estes. Carried unanimously.
